



Holiday Picture Rules & Regulations

WHO CAN ENTER

1. Entrants must be Florida residents, age 18 and older, and have lawful access to the Internet with a valid E-mail address.
2. Employees of Oregon Television, Inc. WOFL FOX 35 ("Sponsor"), WRBW MY 65 and their affiliated companies, advertising and promotion agencies, and immediate family members of each are ineligible.

HOW TO ENTER

1. No purchase is necessary to enter to win. Only one entry per entrant/e-mail address each day. In the event of a dispute, Sponsor will deem each entry to have been submitted by the holder of the e-mail account from which it was sent.
2. Contest begins December 1, 2008 and ends on December 26, 2008. To enter beginning at 5:00am December 1, 2008 access <http://www.myfoxorlando.com> and click on the 'Holiday Pictures' link. Entrants will be asked to enter the email address and password to their myfoxorlando.com account. If entrants do not have an account with myfoxorlando.com they will be prompted to create one before they can register to enter the contest. Entrants will be instructed to enter their email address and create a password for their account, then fill out an online form with their name, address, phone number and age. Once entrants are registered they can complete the contest entry form with name, age, email address and phone number and upload their holiday picture. Photos must be submitted in JPEG format with dimensions at least 640 x 480. Entrants must have the right or permission to submit the photo; professionally taken photos are not permitted. All entries must be received by 5:00pm December 26, 2008.
3. Two (2) entries are chosen at random each weekday of the contest at 5:05pm and shown on My65 (7:00pm-8:00pm). The first two (2) entries randomly selected will be shown on Monday, the next two will be shown on Tuesday and so on until the total of 10 are shown by Friday.
4. Every Holiday photo submitted will be posted in a photo gallery on myfoxorlando.com for the entire contest period. WOFL FOX 35 personnel will judge the contest, the decision of the judges will be final as to all matters, including, but not limited to, whether an entry is received timely, whether a winner is eligible, or whether a person entering should be disqualified.
